No lowering of the bar, no exceptions. I believe I have made this clear in my stance that the project should be subject to a Class 2 environmental assessment, as opposed to the current Class 1.	

I'm constantly interested in solutions that protect the environment, protect our fishing and forestry industries, our overall economy, and honour the First Nations.

As the deadline looms, the ball is in the Mill's court to meet the standards. I can see the effort mounting to exert pressure on the politicians to "extend" the deadline but from where I stand that pressure is better applied to the Mill. They are the ones that must meet the standard.

There are those that say that mill should be "given" more time. Nothing should just be given, it should be earned, and it hasn't been.

I've tried my best to be a positive voice on this file over the last few years but my suggestions have always been dismissed.

- I asked that the Bill include timelines at the outset to hold the Mill accountable and allow people to monitor progress. Instead government failed to properly monitor the Mill's progress and has let all of us, particularly foresters across the province down.
- I asked that any proposal be held to a higher level of scrutiny from the start. That standard wasn't imposed and this eroded public confidence few people trust this government to properly due its job.

I recognize that pressure from sectors of the forest industry for an extension to the Boat Harbour Act is increasing as the Boat Harbour closure date draws closer.

I want you and all MLAs to know that I support the closure of Boat Harbour to pulp effluent on 31 January, 2020.

Why?

- I know the history of broken promises to Pictou Landing First Nation. To break another promise would be adding to past wrong doings and would continue Nova Scotia's legacy of environmental racism.
- I know that Northern Pulp was aware they had a tight deadline, but did not begin designing a new effluent treatment facility for several years.
- I know that when Northern Pulp submitted their project for environmental assessment in January 2019, the company did not provide many essential studies and information requested by government departments, leading to further delay.
