Example Policy Resolution:

Resolution 11: (submitted by Halifax Armdale EDA)

Title of Resolution: Continuing Crisis in Long-Term Care
Intent of resolution: to amend the existing party policy on long-term care.

WHEREAS many nursing homes offer five and six dollar a day meal allowances for residents, one bath a week, one diaper change per day, persistent bed sores, widespread reports of alleged abuse, and instances of people being denied admission or re-admission to nursing homes if they do not have a family doctor;

WHEREAS recent Provincial Budgets have effectively frozen all spending for long-term care or provided only limited funding increases, and continued the moratorium on adding additional beds or facilities;

WHEREAS even before this period of funding restraint, nursing homes were facing chronic underfunding and understaffing problems;



BE IT RESOLVED that the Nova Scotia NDP continue to call on the McNeil government to not only reverse recent cuts, but provide additional funding so that long-term care facilities have the funding they need to serve healthy meals, hire and retain the appropriate number of qualified staff, and provide high quality, compassionate care to residents.

BE IT FURTHER RESOLVED that the Nova Scotia NDP continue to advocate for more nursing home beds and facilities to help alleviate pressures in other parts of the health care system; and that it also press for new, long-promised five-year and ten-year continuing care strategies to be completed as soon as possible with broad, public consultation.

Submitted policy resolutions may be altered on the floor of Convention by an amendment and passed by a simple majority vote of those present.
